"Total income: \$50,132.85 (83% of \$54,660 budgeted)
Total expenses: \$47,763.55 (86% of \$53,605 budgeted)

- Legislative expenses \$42,338.69 (111% of \$38,000 budgeted)
- Organizational expenses \$5,424.86 (26% of \$15,605 budgeted)

Although we came in way underbudget for organizational expenses, remember we drew \$15,000 from reserves to pay for the Choices in Childbirth grant so overall we drew down our reserves a bit. Current assets are \$74,338 as compared to \$89,864 this time last year."
