

STANDING RULES OF PROCEDURE (SROP)

Name: NYSALM Membership Discrepancies and Billing Procedures

ACNM life members who are not NYSALM life members

- 1) All members in this category, including retired members, are sent invoices annually via email. For those who do not have email addresses on file, an invoice is sent by US post.
- 2) Invoices will be sent at intervals of 3 months. After 3 invoices have been sent with no response, a phone call will be made. If the member does not respond by phone, s/he will be removed from NYSALM's membership roster.
- 3) Responses are tracked on the shared document.
- 4) Phone, addresses, emails are updated as members respond.
- 5) Once payment is received, repeat invoices will be sent on an annual basis in the same month when the first payment was made.
