- University of Rochester is hiring a director, still accepting applications
- Canandaigua midwives bought by Thompson (also URMC) with admitting privileges
- Buffalo: Maura Winkler started homebirth/hospital practice; is expanding and plans to hire CM
- Mercy hospital in Buffalo to hire a full time midwife starting in June
 - Midwifery guidelines not updated. Continued pressure present.
- -A new midwife, Laura Hesson, has come to Buffalo/WNY to join a private physician group, which is expanding midwifery services now to 3 out of 4 hospitals in our region.
- Spinning babies workshop planned for Sept 22 in Skaneateles NY.
 - \$2000 in sales, 5 birth workers of color and 10 regular registrations.
 - Need 10 more regular registrations or \$2000 the event becomes financially viable
 - If not, 4 weeks before the event we can cancel without penalty.

Hudson Valley (Marian Seliquini)

- CMO Ruffiah Community HC advise on taking over a midwifery practice and needed to write practice agreement– Good Samaritan
- Rhinebeck/Northern Duchess: LMs do not have admitting privileges,
- tentative plan to do a local/regional meeting

New York City (Trinisha Williams, Anne Gibeau)

- Planning for M4M October 2018, Brooklyn NY

ACOG:

- -New partnerships and collaborations
- -MMR was not passed in Governor's Budget.
 - Gottfried/Joyner sponsoring a bill and to consider revision and protections for reviewers; reworking language and provisions r/t: Confidentiality
 - Quality improvement bill that is taking the back burner till the MMR
- -Governor's task force: advisory function, at the initial stages of mechanics and design
- RHA advised Democratic majority at next session (Nov 2018) may be a better climate to pass this through.
- -MMR what we would like the bill to have (as it doesn't exist vet); look for it on the horizon.
 - Multidisciplinary, full confidentiality agreement/ protections (from subpoena/discovery)
 - Require a reporting mechanism for accountability.
 - 250K appropriate re: MMR
 - Present as a strategy towards addressing maternal/racial health disparities
