- Huge variation throughout the region in malpractice insurance rates and reimbursement rates, particularly between upstate and downstate
- Increased premiums (surcharge) for attending TOLAC births in some areas

- Lobby Day was well attended. Evaluations were positive overall. However, preparation with more time beforehand and readiness to address bills and issues were cited as needing to be strengthened. Costs were as budgeted.
- NYSALM supported or actively lobbied for 9 bills, of which 5 were same-as-bills with versions in both houses and the remaining 4 were Assembly only bills. Of the same-as-bills 3 passed the Assembly while none passed the Senate. All Senate versions stalled in Committee, 3 in January, 1 in February and 1 in March.
- Plans to draft the 2019 legislative agenda for presentation at the December BOD meeting.

New York State MMR Board -

- Legislation was not passed
- Still to be developed with regional focus and collaboration

Region Reports:

Long Island (Ashley Meccariello)

- 1. Northwell Health
 - North Shore University Hospital, and Long Island Jewish Medical Center: Katz Women's Health Center (0.1% births attended by midwives) offer maternity services and NO have full scope midwives on staff.
 - **Huntington Hospital** hospital-based midwifery practice with Michele Mayer LM, Laura Jabbour LM, Jessica Hilsenroth LM, and Lindsay Price LM.
 - Attempts were made at **Southside Hospital** by a group of midwives to initiate the process of obtaining privileges. The outcome last heard was the administration recommended that
 - Midwives partner with existing physician practices and obtain privileges as part of those practices or
 - Midwives form a group (practice or network) and introduce themselves as a
 midwifery service bringing in their own clientele to the hospital. The volume of
 midwifery clients will be an important factor in the consideration process (no
 specific number discussed).
- 2. Nassau University Medical Center (NuHealth- A Northwell Health Affiliate) has five private midwifery practices with admitting privileges (South Shore Midwives- Rochel Leiberman, LM, City Midwifery- Christiane McClosky, LM, Barbara Charles, LM, Salwaa Health Midwifery- Saidah Haziz-Ramadhan LM, Gaia Midwives- Ashley Meccariello, LM, Amanda Sini, LM, Colleen Heinze, LM, WHNP.) They have a water birth suite, but it is hard to utilize due to the frequent shortage of nursing staff.
- 3. **Winthrop NYU Langone** continues to partner with the Long Island Doula Association to offer free doula services to all patients in labor through a volunteering program. Winthrop also is participating in ACNM's Reducing Primary Cesarean Initiative. Melanie Sumersille, LM, Donna Grand, LM and Marilyn Charles, LM have privileges at this hospital. Pending privileges for Jackie Linder CNM (hired by OB Practice). They have wireless monitoring, an early labor walking path, and tremendous nursing support.
- 4. **Stony Brook University Hospital** has acquired Southampton Hospital. The Stony Brook Midwives continue to offer Centering Pregnancy and they now offer a hospital-based doula training program in collaboration with Long Island Doula Association. Also, the Stony Brook Midwives are participating in ACNM's Reducing Primary Cesarean Initiative.
- 5. **South Nassau Hospital** currently has two private practice midwives that have privileges; Diane Lucks (FemmPro OBGYN) and Linda Jaworowski (Gentle Care OB/GYN PC).
- 6. A licensed midwife from Long Island (Elizabeth Morrison, LM) has accepted a position at **Nyack Hospital** (Nyack, NY) providing full-scope midwifery services.

7. Catholic Health Services: Saint Charles, Saint Catherine of Sienna, and Good Samaritan are private catholic hospitals that (according to their website and word of mouth) are not offering full-scope midwifery services.

8. Home Birth:

- Baldwin Midwifery Services, Baldwin, NY (Jeannette Breen LM) attends births at home.
- Gaia Midwives, Kings Park and Riverhead, NY (Ashley Meccariello LM, Amanda Sini LM, Colleen Heinze LM, WHNP) attend births at home and in hospital (Nassau University Medical Center).
- Northshore Midwifery Services, Rocky Point, NY (Janet Titmus LM, Gayle Eckey CPM) attend births at home.
- Salwaa Health Midwifery, Hauppauge and Roosevelt (Saidah Haziz-Ramadhan LM)

9. Long Island Midwives

- Mentor Program: Helping match up graduate-midwives or new-to-practice midwives with experienced/seasoned midwives as mentors.
